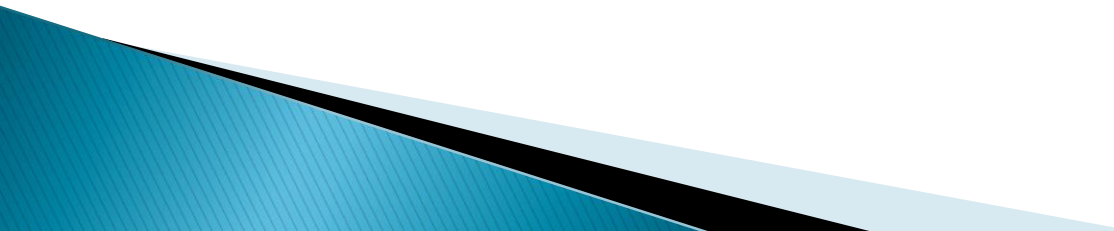

2019 Annual PREA Report

History:

PREA was enacted in 2003 by Congress to address the problem of sexual abuse of persons in the custody of U.S. correctional agencies. The Bureau of Justice created the National Prison rape Elimination Commission and charged it with developing draft standards for the elimination of prison rape.

Those standards were published in June 2009, and were turned over to the Department of Justice for review and passage as a final rule August 20, 2012.



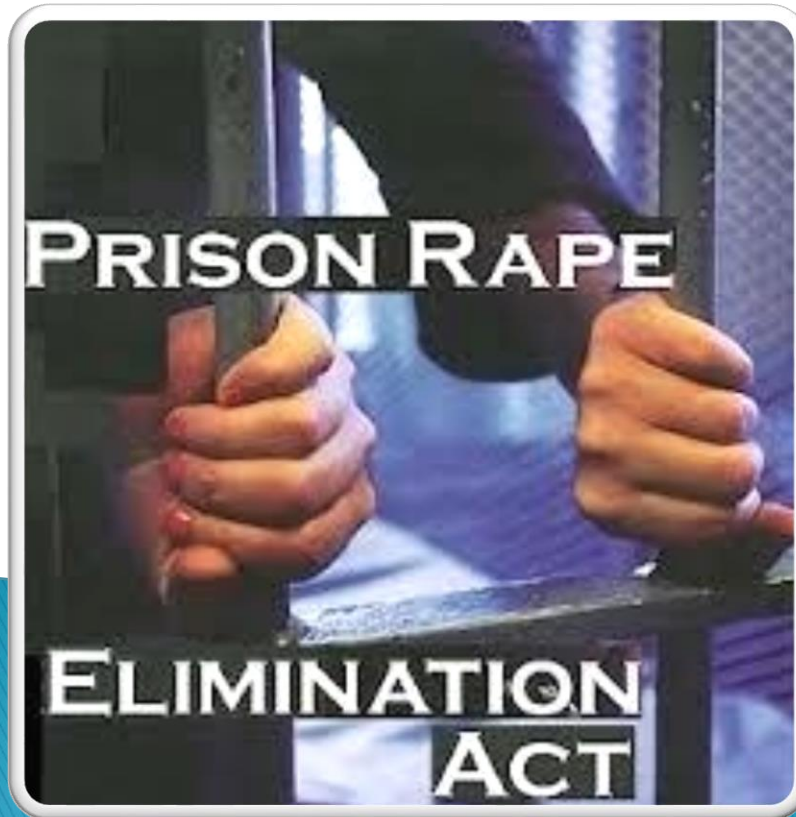
2019 Annual PREA Report

The Santa Rosa Sheriff's Office recognized the importance of the new legislation-

Detention Division adopted a zero tolerance on issues pertaining to sexual abuse and sexual harassment. In 2013 the entire agency took a proactive stance implementing the 46 PREA standards that apply to adult jails / prisons; and educating both staff and inmates on recognizing, preventing, and eradicating sexual abuse and sexual harassment in the confinement setting.

In February 2014, with hard work and dedication from all, The Santa Rosa Sheriff's Office – Detention Division became the first adult prison / jail to achieve PREA compliance in the United States.

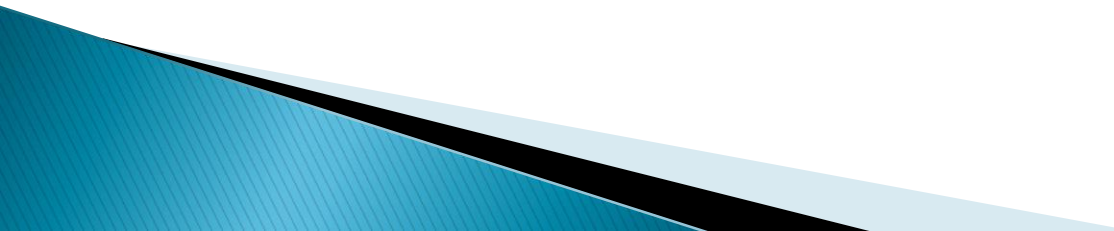

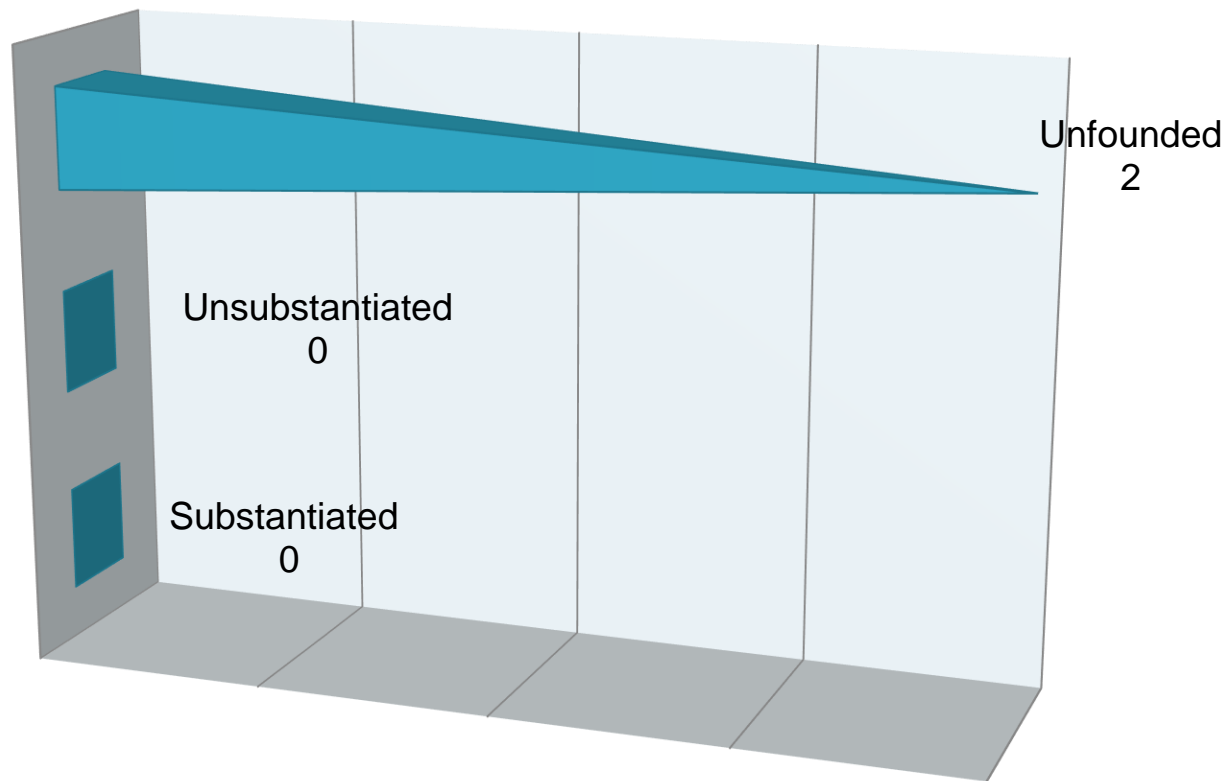
Analysis/Corrective Action:

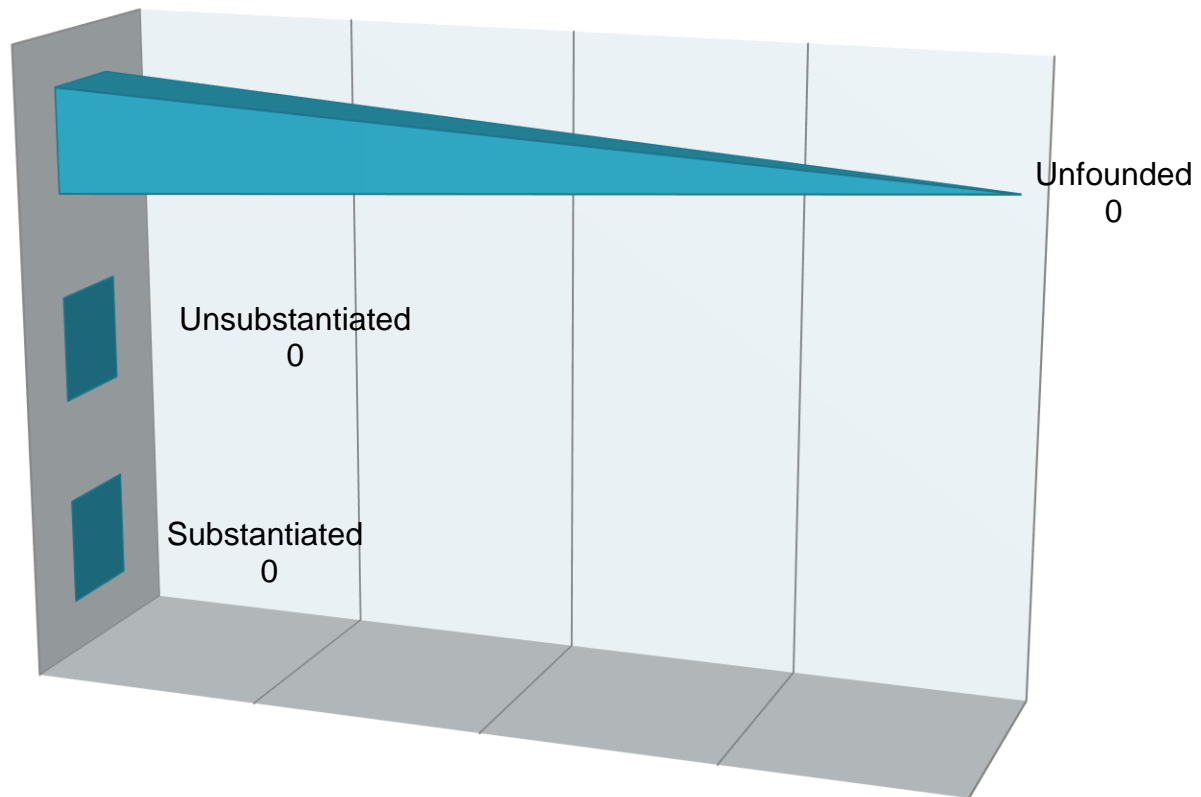

- ❖ **Substantiated allegation** – an allegation that was investigated and determined to have occurred.
 - ❖ **Unfounded allegation** – an allegation that was investigated and determined not to have occurred.
 - ❖ **Unsubstantiated allegation** – an allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.

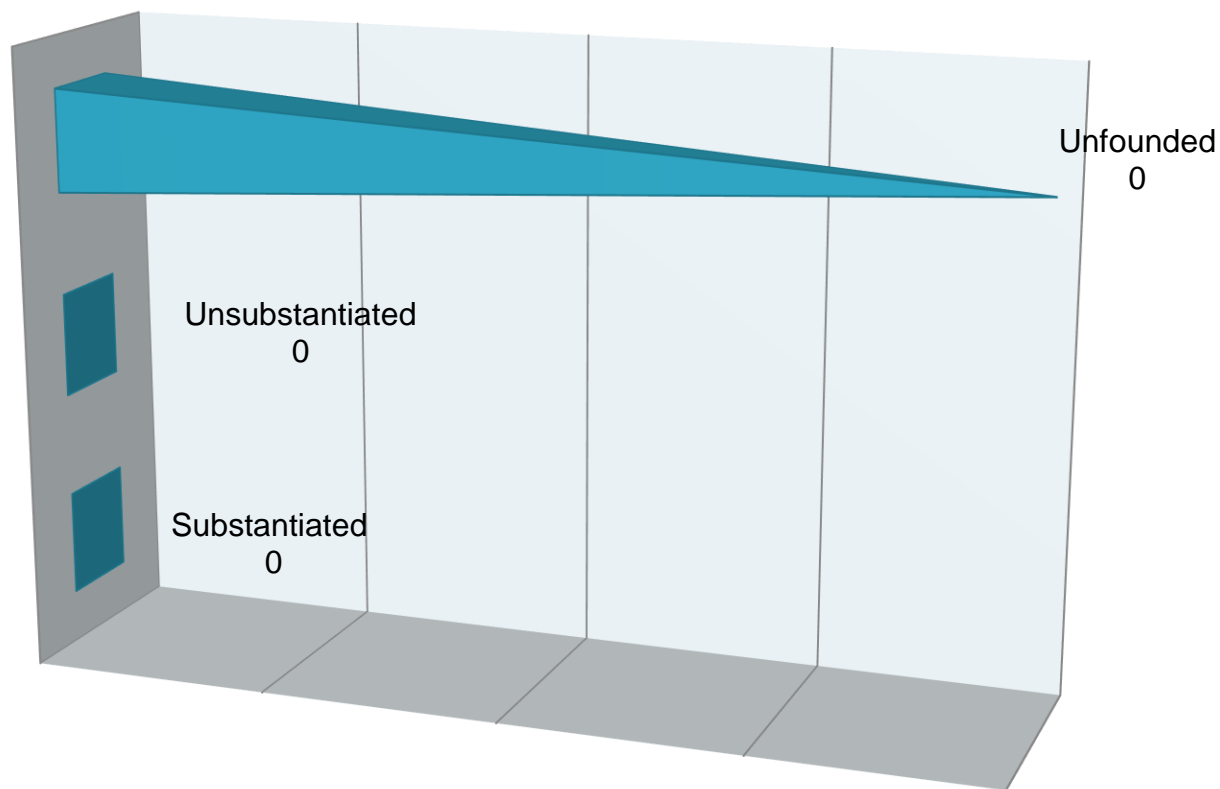

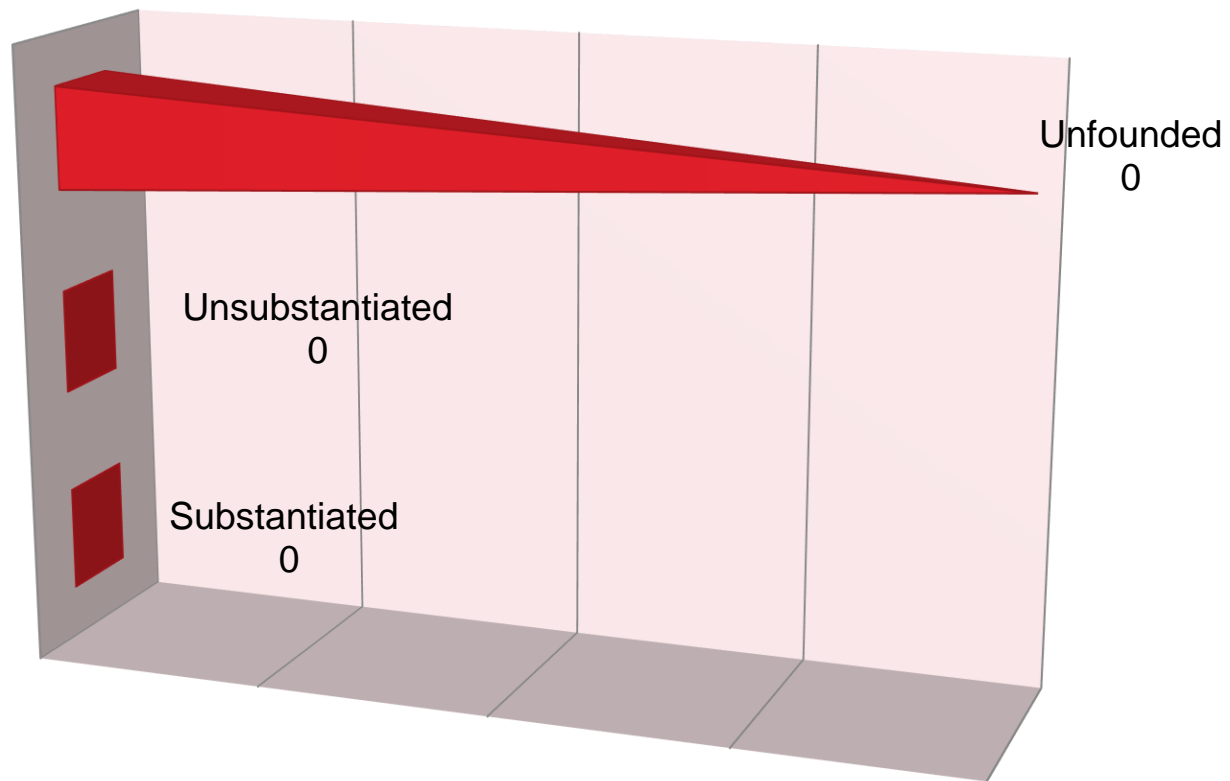
